

**Beko plc October 4<sup>th</sup> – November 7<sup>th</sup> 2018**  
**3 months Finish Promotion - Terms and Conditions**

1. This Finish Promotion (the “**Promotion**”) is offered by Beko plc. (the **Promoter**), a company registered in England and Wales with registered office at Beko House, 1 Greenhill Crescent, Watford Herts, WD18 8QU, company registration number 02415778, in conjunction with RB UK Commercial Limited (“**RB UK**”), a company registered in England and Wales, under company registration number 08784077, with its registered office at 103-105 Bath Road, Slough, Berkshire, SL1 3UH.
  2. This Finish Promotion (the “**Promotion**”) entitles Qualifying Participants (as defined below) to a three (3) months’ supply of Finish Quantum products (the “**Finish Products**”) specifically:
    - 1 pack of 72 Finish Quantum tablets;
    - 1 x 700ml bottle of New Finish Gel (equates to 28 washes); and
    - 250ml of Finish Rinse Aid and

Claimants should allow up to forty-five (45) days for delivery of their Finish Products from date of receipt of their claim form and copy sales receipts. Only one entry allowed per household and only 1 attempt at delivery will be made.

7. Delivery will be to the address provided on the claim form.
8. RB UK does not accept any liability for the Finish Products being lost or damaged during delivery provided it can prove that it sent the Finish Products by registered address to the postal address provided by the Qualifying Participant.
9. This offer is subject to availability. The Promoter and RB UK each reserves the right to provide a substitute product of equivalent or higher value in the unlikely event of unavailability of the product.
10. Note that the product is non-transferable and no cash alternative shall be offered.
11. The Promoter and RB UK each accepts no responsibility for any entries that are incomplete, illegible, corrupted, lost, damaged, delayed or fail to reach them during the term of the Promotion.
